DURING 2024, THE HOLLY SPRINGS FOOD CUPBOARD DISTRIBUTED FOOD TO 1,396 HOUSEHOLDS. CLIENT VISITS INCREASED BY 19% OVER 2023. IN 2024, AN AVERAGE OF 520 HOUSEHOLDS RECEIVED FOOD EACH MONTH AND AN AVERAGE OF 586 STUDENT BAGS WERE DISTRIBUTED MONTHLY TO K-12 STUDENTS IN THOSE HOUSEHOLDS. 477 HOUSEHOLDS RECEIVED SPECIAL THANKSGIVING MEAL PACKAGES. PROGRAM SERVICE EXPENSES INCLUDED THE PURCHASE OF FRESH PRODUCE, MEAT, MILK, EGGS, AND OTHER FOOD PURCHASES TO ENABLE THESE DISTRIBUTIONS.
